## CalFresh Expansion for SSI Recipients Background

Assembly Bill 1811, the Fiscal Year (FY) 2018-2019 Human Services Omnibus Trailer Bill, reverses the CalFresh eligibility policy known as "cash-out" under which Supplemental Security Income (SSI) / State Supplemental Payment (SSP) recipients are ineligible for CalFresh. On **June 1, 2019**, individuals receiving or authorized to receive SSI/SSP are eligible for CalFresh, provided all other eligibility criteria are met. The bill also augments the grant amount for the Cash Assistance Program for Immigrants (CAPI).

AB 1811 creates two new programs for ongoing CalFresh households with previously excluded SSI/SSP recipients:

- \* Supplemental Nutrition Benefit (SNB) Program
- \* Transitional Nutrition Benefit (TNB) Program

## Two Types of Households: *Newly Eligible* and *Ongoing*

Starting on **June 1, 2019**, counties will determine CalFresh eligibility for newly eligible households and ongoing households with active CalFresh benefits.

- A newly eligible household is defined as a household in which includes an SSI/SSP recipient(s). Determination of eligibility will be based on revised CalFresh rules.
- An **ongoing household** is defined as an ongoing CalFresh household that includes a mix of included members and at least one excluded member who is an SSI/SSP recipient. At their annual review or if they voluntarily request for the SSI/SSP recipient to be added to the CalFresh assistance unit.

### Overview of AB 1811

Supplemental Nutritional Benefit Program (SNB)

Establishes a supplemental benefit program for existing households who experience a benefit reduction due to the policy change.

Transitional Nutritional Benefit Program (TNB)


Establishes a supplemental benefit program for existing households who lose CalFresh due to the policy change.

Allows SSI/SSP recipients to qualify for CalFresh if otherwise eligible

Increases Cash Assistance
Program for Immigrants
(CAPI) benefits by \$10 per
person in standardization
with the SSI/SSP grant
amount

The total SSI/SSP grant amount will NOT decrease recipients may receive both SSI/SSP and CalFresh benefits.

## Supplemental Nutrition Benefit (SNB) Transitional Nutrition Benefit (TNB) Determination



**NOTE:** SNB and TNB programs ONLY apply to ongoing CalFresh households with an excluded SSI/SSP recipient on June 1, 2019.

### Implementation of New CalFresh Policy

- May 20, 2019, the eligibility system will enable staff to enter the eligibility information of SSI/SSP recipients from new applications or for previously excluded persons who will be added to active cases.
- Eligibility will be determined and appropriate notices will be issued to customers, depending on the status of their case.
- Any households requesting to add an SSI/SSP recipient(s) prior to their annual redetermination or semi-annual report (SAR 7) will be informed of the possibility of a benefit decrease and encouraged to make an informed decision.



## Social Security Administration's Role: Joint Application Processing

- Beginning June 2019, Social Security Administration (SSA) offices will inform SSI/SSP recipients of their right to apply for CalFresh benefits.
- ► Households with <u>only SSI/SSP</u> applicants or recipients, SSA Technicians will inform them that they can assist by using an online assistance tool to submit CalFresh applications or the option to apply directly with the county.
- Applications for households with SSI/SSP individuals <u>and</u> non-SSI/SSP members will be referred to apply online or contact the Human Services Agency.
- SSA-assisted applications will not require an additional interview. However, verification of expenses that can be used as deductions to maximize benefits will be requested by the Human Services Agency.

### Social Security Administration's Role: Joint Application Processing Continued

- In addition to assisting the customer with submission of their CalFresh application, the SSA Technician can sign the application on behalf of the household.
- Customers may elect to complete a paper application for CalFresh benefits which the SSA Technician will assist in completion and submission to the Human Services Agency within one business day of receipt.
- Should information provided by SSA contradict that provided by the household the County may request verification to resolve the conflict.
- Certification periods for households in which all members are elderly and/or disabled, and no earned income will be 36 months.
- Certification periods for households in which all members are elderly and/or disabled and have earned income will be 24 months.

## How can you HELP?

- Review with customers the income limits: gross & net to determine if they will be potentially eligible.
- Help customers log into www.C4Yourself.com and enter their application.
- Help gather verifications needed Income (other than SSI), rent, medical expenses, child/dependent care expenses, and bank statements.
