

## Kings County Tobacco-Free Partnership Meeting

Thursday, September 27, 2018 • 10:00 – 11:15am • Kings County Health Dept., Bldg. 5 Auditorium

- I. Keith Winkler welcomed those in attendance and everyone introduced themselves.
- II. <u>Minutes:</u> The group reviewed the August meeting minutes. Motion to approve as corrected, Oralia Vallejo, second, Gabriel Ledesma, motion carried.

## III. Kings County Tobacco Control Program Update

- Oralia shared that they will hold a Neighborhood Conversation on October 3<sup>rd</sup> at Montgomery Crossing apartments in Lemoore.
- Oralia shared that they will be holding their first second hand smoke training for apartment managers and community members on December 13<sup>th</sup>.
- They are looking for youth 18 years of age and older to conduct. Tobacco purchase survey in Avenal and Lemoore.
- Gabriel shared that the Avenal youth coalition is setting up by-laws and positions. The kids would like to receive information on various careers (e.g. military, dental, etc.)
- Oralia will be attending Rock the Arbor in Lemoore tomorrow evening looking for volunteers to take a public opinion poll.
- Oralia is planning a Community Forum for their tobacco retail licensing objective, at Avenal and Lemoore High Schools. She will be finalizing dates soon. The events will be open to youth and the community.

## IV. California Health Collaborative Update:

## Regional Advocates Countering Tobacco (ReACT) Project

- Objective 1 (Youth engagement)- We have 4 active Coalitions: Reedley, Hanford, Corcoran and Sanger (New). Recruitment for additional Corcoran youth will take place on October 19<sup>th</sup> at Corcoran High School.
- Objective 2 (Smoke free parks)- Meeting with Hanford City Council Member on Wednesday, October 3, 2018 (last member needed to educate on smoke-free parks). We are looking to collect Public Opinion Polls at local grocery stores to gather more data.
- Objective 3 (Zoning)- Staff met with the Mayor of Sanger to educate him on zoning and tobacco retailer density. ReACT has been placed on the City Council Agenda for October 18<sup>th</sup>, 2018, and will be providing an educational presentation on zoning.

## **Unidos Por Salud Project**

- Objective 1 We are currently planning on scheduling the strategic planning sessions in the communities of Dos Palos and Wasco. The tentative date for Hanford's strategic planning session is Monday, November 19<sup>th</sup>, 2018. More details to come.
- Objective 2- We had a strategic planning session in the city of Woodlake last Wednesday, September 19<sup>th</sup>. We are planning on for the Coalinga strategy session in the upcoming months

Objective 3- We have a youth coalition up and running in the City of Dos Palos. We are trying to
get into the schools in the cities of Reedley and Wasco to begin recruitment for two other youth
coalitions.

### **API PACT Project**

- Objective 1- Support an ordinance restricting the sale of flavored tobacco within 1,000 feet of schools and youth-sensitive areas. API PACT completed the Midwest Academy Strategy Session for Visalia and Livingston.
- Objective 2- Educate event organizers and venue operators about secondhand smoke. Support them in adopting a voluntary smoke-free policy for their event or venue. API PACT plans to hold a Midwest Academy Strategy Session for the Fresno area in October. Another strategy session for the counties of Kings, Kern, and Tulare will be planned soon. Details will follow in the future.
- Objective 3- API PACT is recruiting youth from high schools in Visalia and Livingston. It is an on-going activity.
- V. Cristhian shared Legislative Updates: See attached handout.

#### VI. Other New Business

Cristhian shared the Tobacco-Free Partnership Recruitment Packet which includes a recruitment
flyer, information about flavored tobacco, menthol cigarettes, Tobacco Control Program
overview, tobacco retailer license information sheet, smoke-free parks information sheet,
Hanford Sentinel article on a tobacco sting operation by Hanford Police. The recruitment subcommittee is currently working on a membership form.

## VIII. Guest Speaker

 Maria Carbajal with the University of California and Natural Resources shared about their Promotora Model in Kings County. Promotoras are community member volunteers who reach out and gather information about community resources and then take the information back to their communities. They educate, empower, and advocate for community change by sharing information and resources to families in need. UCCE provides nutrition classes and physical activity. They are looking for Promotoras in every community.

## California Legislative Update

The 2017-2018 legislative session ended on Friday, August  $31^{\text{st}}$ . Bills that were approved by the legislature will now move to the Governor's desk for final approval. The Governor has until Sunday, September  $30^{\text{th}}$  to either approve or veto the bills. Any bills that were not approved by the legislature are no longer eligible to move forward and cannot be brought back up next year.

Five tobacco-related bills were approved by both the Senate and Assembly and sent to the Governor for his action. The governor has three options, (1) he can sign the bill into law, which allows the bill to take effect, (2) he can veto the bill, which stops the bill from taking effect, or (3) he can do nothing, which allows the law to take effect.

## Five tobacco-related bills are pending before the Governor:

AB 1097 (Levine – D, San Rafael) State beaches and parks, smoking ban

AB 2020 (Quirk - D, Hayward) Cannabis: local jurisdiction licensees: temporary event license

SB 835 (Glazer - D, Orinda) Parks: smoking ban

SB 836 (Glazer - D. Orinda) State beaches: smoking ban

SB 1408 (Pan - D, Sacramento) Cigarettes: seizure

## Two tobacco-related resolutions will not be moving forward:

ACR 254 (Holden - D, Pasadena) Smoke-free multiunit housing

SCR 143 (Pan - D, Sacramento) Smoking: youth: motion picture industry





## Five tobacco-related bills are pending before the governor:

## AB 1097 (Levine - D, San Rafael) State beaches and parks, smoking ban

Assembly Bill 1097 makes it a crime to smoke or dispose of cigar and cigarette waste at designated non-smoking picnic areas within state parks and coastal beaches. On August 24<sup>th</sup>, the bill was amended to only apply to picnic areas instead of entire state parks and beaches and the fine was decreased to \$25. **Status:** AB 1097 now awaits action by the Governor.

January 9<sup>th</sup>: passed the Assembly Water, Parks & Wildlife Committee 10-4 (1 member abstaining/not voting)

January 18th: passed the Assembly Appropriations Committee 12-5

January 29th: passed the Assembly 46-24 (7 members abstaining/not voting)

June 12th: passed the Senate Natural Resources and Water Committee 7-2

July 2<sup>nd</sup>: unanimously passed the Senate Appropriations Committee

August 29th: passed the Senate Floor 27-12 (1 member abstaining/not voting)

August 31st: Senate amendments approved by the Assembly Floor 57-22 (1 member abstaining/not voting)

#### AB 2020 (Quirk - D, Hayward) Cannabis: local jurisdiction licensees: temporary event license

Assembly Bill 2020 would allow the state to issue temporary event licenses to any venue that will be selling cannabis products onsite. This would not supersede any local ordinances, such as zoning, land use, or business license requirements, requirements to reduce exposure to secondhand smoke, or completely outlaw certain types of businesses. The state may grant full power to administer licenses to counties and incorporated cities if they so choose. Licenses may be denied if the event does not comply with local smokefree ordinances. Venues approved for this license must have an area where access is restricted to persons 21 years of age or older, have the cannabis consumption not visible from any public place or nonage-restricted area, and must also not sell or provide for consumption alcohol or tobacco products. On June 18<sup>th</sup>, the bill was amended to include additional restrictions on vendors. On August 20<sup>th</sup>, amendments were taken to give local law enforcement the ability to monitor and shut down events for immediate public health and safety purposes.

Status: AB 2020 now awaits action by the Governor.

April 17<sup>th</sup>: passed the Assembly Business and Professions Committee 13-1 (2 members abstaining/not voting)

May 9th: passed the Assembly Appropriations Committee 12-4 (1 member abstaining/not voting)

May 29th: approved by the Assembly Floor 60-16 (2 members abstaining/not voting)

June 25th: passed the Senate Business, Professions, and Economic Development Committee 8-1

August 27th: approved by the Senate Floor 30-9 (1 member abstaining/not voting)

August 29th: Senate amendments approved by the Assembly Floor 61-15 (4 members abstaining/not voting)

#### SB 835 (Glazer - D, Orinda) Parks: smoking ban

Senate Bill 835 would make it a crime to smoke or dispose of cigar and cigarette waste within a state park. Anyone who violates this law could receive a fine up to \$25. This bill would allow the Director of Parks and Recreation at any affected location to designate exempted areas where smoking would be permitted. On August 23<sup>rd</sup>, the disposal clause was amended so that cigar and cigarette waste may be disposed of in an appropriate receptacle. **Status:** SB 835 now awaits action by the Governor.

March 13<sup>th</sup>: passed the Senate Committee on Natural Resources and Water 6-2 (1 member abstaining/not voting)

May 25th: passed the Senate Appropriations Committee 5-2

May 29th: approved by the Senate Floor 26-11 (2 members abstaining/not voting)

June 12th: passed the Assembly Water, Parks & Wildlife Committee 10-5

August 16th: passed the Assembly Appropriations Committee 12-5

August 29th: approved by the Assembly Floor 55-25

August 30th: Assembly amendments approved by the Senate Floor 26-11 (3 members abstaining/not voting)





## SB 836 (Glazer - D, Orinda) State beaches: smoking ban

Senate Bill 836 would make it a crime to smoke or dispose of cigar and cigarette waste on a state coastal beach. Anyone who violates this law could receive a fine up to \$25. This bill would allow the Director of Parks and Recreation at any affected location to designate exempted areas where smoking would be permitted. On August 23<sup>rd</sup>, the disposal clause was amended so that cigar and cigarette waste may be disposed of in an appropriate receptacle.

**Status:** SB 836 now awaits action by the Governor.

March 13th: passed the Senate Committee on Natural Resources and Water 6-2 (1 member abstaining/not voting)

May 25th: passed the Senate Appropriations Committee 5-2

May 29th: approved by the Senate Floor 27-11 (1 members abstaining/not voting)

June 12th: passed the Assembly Water, Parks & Wildlife Committee 10-5

August 16th: passed the Assembly Appropriations Committee 12-5

August 29th: approved by the Assembly Floor 54-25 (1 member abstaining/not voting)

August 30th: Assembly amendments approved by the Senate Floor 26-11 (3 members abstaining/not voting)

## SB 1408 (Pan - D, Sacramento) Cigarettes: seizure

Current law bans the sale, offering, or possession of cigarettes that do not meet specific manufacturing criteria, but offers an exemption for cigarettes produced outside California. Senate Bill 1408 would delete the exemption and make these cigarettes contraband, which can be seized and disposed of by law enforcement or the state Department of Tax and Fee Administration. Any person who fails or refuses an inspection will be subject to a \$1,000 civil penalty. Status: SB 1408 now awaits action by the Governor.

April 16<sup>th</sup>: unanimously approved by the Senate Business, Professions and Economic Development Committee

May 21st: approved by the Senate Floor 35-2 (2 abstaining/not voting)

June 28<sup>th</sup>: passed the Assembly Governmental Organization Committee 19-1 (1 member abstaining/not voting)

August 8th: passed the Assembly Appropriations Committee 15-2

August 23<sup>rd</sup>: approved by the Assembly Floor 68-5 (7 abstaining/not voting)





## Two tobacco-related resolutions will not be moving forward:

### ACR 254 (Holden - D, Pasadena) Smoke-free multiunit housing

Assembly Concurrent Resolution 254 encourages local jurisdictions throughout California to adopt policy to reduce smoking in existing and newly constructed multiunit housing.

**Status:** ACR 254 was introduced on June 13<sup>th</sup> and was referred to the Assembly Committee on Housing and Community Development but failed to receive a hearing.

### SCR 143 (Pan - D, Sacramento) Smoking: youth: motion picture industry

Senate Concurrent Resolution 143 encourages the California Department of Public Health, the Attorney General, and other state and local agencies to work with the motion picture industry to eliminate depictions of smoking in the entertainment industry.

Status: SCR 143 failed to receive enough votes to move beyond the Assembly Health Committee.

June 6th: passed the Senate Health Committee 6-0 (3 member abstaining/not voting)

July 2<sup>nd</sup>: Approved by the Senate Floor 24-8 (7 abstaining/not voting)

August 21st: failed in the Assembly Health Committee 7-0 (8 members abstaining/not voting)
