- Mandated child abuse reporters include all those individuals and entities listed in <u>PC section</u>
 11165.7.
- Any mandated reporter who has knowledge of or observes a child, in his or her professional capacity or within the scope of his or her employment, whom he or she *knows or reasonably suspects has been the victim of child abuse or neglect* shall report such suspected incident of abuse or neglect to a designated agency immediately or as soon as practically possible by telephone and shall prepare and send a written report thereof within 36 hours of receiving the information concerning the incident. (PC section 11166(a).)

Types of Response

What happens after the call?

Immediate Response

 Meets criteria for response within 24 hours. (Kings 2-hours)

10-Day Response

Meets criteria for response within 10-days

Evaluated Out

 Does not meet criteria for response. Referral will be evaluated out.

The child abuse reporting hotline is open 24 hours to receive suspected child abuse reports from Community members. Each report is assessed and if criteria is met an investigation response will be conducted within 24 hours or within 10 days.



Hotline Dashboard

In 2022 Kings received a total of 1035 reports of suspected child abuse.

Emergency Response

- If an investigation reveals a child is at risk and/or unsafe due to abuse or neglect, preventative measures will be implemented. At times prevention may involve court involvement while that child continues to remain in the home with CWS oversight. If safety can not be achieve a child may be temporarily removed from the care of the parents, care takers or legal guardians pending a Court hearing.
 - Safety Plan- (Patch Plan or Family Plan) Time limited prevention can be provided by: community based services, child and family team or within the agency.
- If a child is removed from their home, we must investigate if we can return to a parent or guardian, complete family finding efforts and initiated placement with family or non-related extended family members when possible and appropriate.



Resource Family Approval

The RFA Program includes assessing all families who wish to provide out-of-home care for children and adoptive or guardianship families. The RFA Program ensures standards of safety are met in each resource family home. The RFA Program includes licensed foster homes, resource care providers, adoption, guardianship, and recruitment services for care providers in Kings County. Resource families are necessary to Kings County Child Protective Services (CPS), as in the event that a child cannot permanently return home to their parents, CPS strives to place children for adoption or guardianship in safe, nurturing, permanent homes.

Qualifications to become an RFA home include (but are not limited to):

- Completion of a Resource Family Application
- Criminal background clearance
- Pre-approval and post-approval training
- Personal references
- Financial resources adequate to meet the needs of your existing household
- Combined home environment and permanency assessments

Primary Goals for Family Reunification

- Court Ordered Family Reunification (FR) Services- provide time-limited services to families whose children cannot remain safely in the home and have been placed in foster care by the Juvenile Court. The goal of the FR Services is to help the family overcome safety issues so that children can be reunited with parents or guardians
- Strategies are implemented to build on family strengths and address concerns. Such strategies may include family engagement, maintaining family and cultural connections, regular and frequent visits among family members, and connecting families to services and resources in the community.
- Kings County offers many services and resources to families to address their case plan goals. Services may include, but are not limited to, parenting classes, substance abuse treatment, drug testing, domestic violence treatment, referrals to emergency childcare, and bringing families home and mental health services.

Primary Goals for Family Maintenance

- Court Ordered Family Maintenance (FM) Servicesprovides time-limited services to children in their homes, aimed at preventing or mitigating neglect or abuse. A primary goal of Family Maintenance Services is to allow children to remain safely in their own homes, by providing services and supervision for the family.
- Voluntary Family Maintenance Services-Families whose children are at risk of neglect or abuse, and who are willing to accept voluntary services from Child Welfare Services, may also be eligible for Voluntary Family Maintenance Services if the children can safely remain in the home while services are being provided.



Primary goals for Adoption Unit



Adoption Services- The Adoption program is designed to provide a permanent family for those children who, because of neglect or abuse, cannot safely remain at home or return to the home of the parent(s). Adoption is a legal process which **permanently gives parental rights to adoptive parents**. Adoption means taking a child into your home as a permanent family member. The goal of the Adoption Unit is to ensure that each child has the most stable and loving home available in which to grow up.

Guardianship

Permanency can be obtained through adoption, but also through legal guardianship. Resource Parents/Relatives can assume legal guardianship of a child in out-of-home care **without termination of a child's parental rights**, as is required for an adoption. A guardianship is a legal relationship in which the court appoints someone other than a parent to care for the child and manage the child's affairs.

The guardian is given many of the rights and responsibilities of a parent. Legal guardianship is more durable than a simpler transfer of custody to caretakers. Some financial assistance is available to caretakers who assume legal guardianship of a child from out-of-home care.

Permanency Planning

The overall goal for Permanency Planning is to find permanency for children in out of home care whether this means legal guardianship, adoptions, tribal customary adoption, return home or independent living.

- Building and support natural connections
- Safety and wellbeing
- Family Finding

Extended Foster Care AB12/ILP

Assembly Bill 12 was signed into law on September 30, 2010 and took effect on January 1, 2012. AB 12, and the subsequent AB 212, implement provisions of the Federal Fostering Connections to Success and Increasing Adoptions Act of 2008 (PL 110-351) to improve outcomes for youth in foster care. A provision of the Federal Fostering Connections to Success law permits states to extend title IV-E assistance to eligible child welfare or probation youth that remain in foster care up to age 21.

- Eligibility and Criteria
- Independent Living Program
 - Starts at age 14 years (State 16 years)
 - Transitional Independent Living Plan
 - Classes/Activities
